APPOINTMENT ORDER

The Principal of St. Xavier's College, Ahmedabad, on behalf of the Ahmedabad St. Xavier's College Society is pleased to make the following appointment at St. Xavier's College, Ahmedabad.

Mr. Parmar Kirtankumar C. has been appointed **Adhyapak Sahayak in Statistics** at St. Xavier's College, Ahmedabad, with effect from **1st October, 2012**, as per letter No:Ushik/Kavat/12/ISC4/35137 dated 18/06/2012 of Commissioner of Higher Education, Gandhinagar, and Order of the High Court vide SCA No.3239/2012 dated 13/06/2012. His adhoc salary will be Rs.7,500/- (fixed) per month, for a period of five years, payable under the rules of St. Xavier's College, Ahmedabad, in force from time to time.

This appointment is subject to the following conditions:

- That this appointment is for a period of five years and is subject to periodic evaluation by both the Staff and students of the College, following which, provided s/he fulfills all conditions, s/he will be absorbed in the appropriate scale as per prevailing Government norms.
- That if you are not NET/SLET qualified and have M.Phil Degree, then you are required to complete the Ph.D. Degree within five years from the date of appointment.
- That as per guidelines of St. Xavier's College Management, those who do not have a Ph.D. Degree, are expected to complete the Ph.D. Degree within five years from the date of appointment and those who have a Ph. D. Degree, are expected to continue extensive research work in the areas of Statistics.
- That s/he is expected to undertake teaching/Practical work assigned by rotation to the academic staff of the Statistics Department.
- That s/he is expected to take active interest in the marginalised students and other co- and extra-curricular activities.
- That this appointment is subject to the outcome of the decision to be taken by the Hon'ble Gujarat High Court in SCA No.:3239/2012 dated 13/06/2012.
- That this appointment is also subject to the conditions that s/he will do his/her duty to the satisfaction of the College and the concerned Department. It will also be his/her duty as a condition of appointment to abide by the rules of St. Xavier's College, Ahmedabad, in force from time to time in respect to both conduct and discipline.
